



LIMITED WARRANTY

Wilsonart® Flooring For Commercial Non-Industrial Interior Flooring Applications

Effective February 1, 2007

Wilsonart International, Inc. ("Wilsonart") warrants its flooring products for commercial non-industrial interior flooring applications ("Commercial Non-Industrial Interior Flooring Products") to the original purchaser, under normal use and service, against the stated warranty coverages and for the stated warranty periods. This warranty is extended for the specified period after the date of purchase by the original purchaser and only is extended to, and may only be enforced by, that purchaser. **THIS WARRANTY IS NOT TRANSFERABLE.** This warranty only applies to a Commercial Non-Industrial Interior Flooring Product, which has been installed in an interior commercial application with BlueFusion® adhesive and Wilsonart Commercial Cushion underlayment by a professional installer and remains installed at that original interior installation location. This warranty is expressly conditioned upon submission of proof of date of purchase.

***DEFINITIONS:**

- To be covered, "Wear" must be through the decorative print. Gloss reduction is not wear.
- To be covered, "Fade" must be due to exposure to sun or electrical light.

EXCLUSIONS:

Wilsonart® Flooring is a laminate and wood product, and therefore, seasonal changes may result in expansion and contraction to individual planks/tiles, causing minor separation to occur; this is not a defect in the product and is not covered by this warranty.

This warranty shall not apply to damage arising from any of the following:

- accidents, abuse or misuse;
- exposure to extreme temperatures or extreme relative humidity;
- failure to install or use the flooring product in accordance with Wilsonart Commercial Flooring Installation Instructions;
- improper maintenance;
- improper adhesive; and
- industrial commercial applications.

This warranty shall be void and of no further force or effect if any of the following events occur:

- the product is removed from the original place of installation;
- sale of the location where the product was originally installed; and
- unauthorized repairs to the product.

This warranty shall not apply to Wilsonart Commercial Non-Industrial Interior Products which have not been installed by a professional installer.

WHAT WILSONART WILL DO:

If a Commercial Non-Industrial Interior Flooring Product is found not to have performed as warranted during the specified warranty period:

For warranty claims made during the first year after date of purchase: If the Commercial Non-Industrial Interior Flooring Product was installed by a professional installer, Wilsonart will pay the reasonable material and labor costs to repair or replace, at its option, the warranted product.

For warranty claims made after the first year of purchase: If the Commercial Non-Industrial Interior Flooring Product was installed by a professional installer, Wilsonart will pay a percentage of the reasonable material and labor costs for repair or replacement, at its option, of the warranted product. This percentage will be based on the number of years from the date of purchase and the remaining warranty period for the particular product. For example, Wilsonart will pay 53% of the reasonable material and labor costs on an approved claim submitted 7 years after the date of purchase of a product, such as Wilsonart Commercial Flooring, which is covered for a 15 year period. If a claim is approved with respect to Classic, which has a 5 year warranty, in the 2nd year after the date of purchase, Wilsonart will pay 60% of the reasonable material and labor costs.

No repair or replacement under this warranty shall extend the warranty period.

Any repair or replacement under this warranty is limited to repair or replacement with colors and styles of products available at the time of repair or replacement. If the original design is no longer available, Wilsonart has the right to substitute another Wilsonart design of equal or less value than the original flooring, and the warranty claim will be calculated and paid on the basis set forth above.

WHAT YOU NEED TO DO:

To make a claim under this warranty, the original purchaser shall contact the commercial contractor or retailer from which the flooring product was purchased. All warranty claims will be processed through this commercial contractor or retailer. The original purchaser must provide proof of date of purchase. The return of a warranty registration card is not required for warranty coverage and is not proof of purchase.

THE FOREGOING SHALL CONSTITUTE THE EXCLUSIVE REMEDY OF THE PURCHASER AND THE EXCLUSIVE LIABILITY OF WILSONART.

THE ABOVE WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESS WARRANTIES WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED. NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL APPLY.

WILSONART SHALL NOT, UNDER ANY CIRCUMSTANCES OR UNDER ANY LEGAL THEORY, BE LIABLE TO THE PURCHASER OR ANY OTHER PERSON FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE, INCLUDING WITHOUT LIMITATION DAMAGES TO, OR LOSS OF USE OF, PROPERTY, DAMAGES FOR LOSS OF PROFITS OR REVENUES OR ANY OTHER DAMAGES ARISING FROM THE ORIGINAL PURCHASER'S PURCHASE. WILSONART'S LIABILITY WILL IN NO EVENT EXCEED THE PURCHASE PRICE OF THE PRODUCT.

No agent, dealer, employee or representative of Wilsonart nor any installer, fabricator or other person is authorized to modify this warranty in any respect.

The invalidity of all or a part of any of the provisions of this Limited Warranty shall not affect or invalidate any other provision of this Limited Warranty.
